6.1 (ANSA) - ROME, NOV 2 - Moody's said Wednesday that it has changed its assessment of the outlook for Italy's banking system from stable to negative. The ratings said it expects business conditions for Italy's banks to deteriorate further in the next 12-18 months, in particular in relation to the quality of their loans and earnings. It said expects Italy to post zero growth in 2023 after a forecast rise of 2.7% in GDP in 2022, due to the war in Ukraine, the energy crisis and high inflation. (ANSA).	estratto
6.2 ANSA) - ROME, OCT 6 - Italy's new 'Volocopter' air taxi copter had its first test flight at Rome's Fiumicino Airport on Thursday. Airport handling company ADR Chairman Claudio De Vincenti said "less than a year after the presentation at Fiumicino of the first Volocopter prototype, today is a first concrete step, entering the future, for urban air mobility". He thanked the Atlantia motorway and airport infrastructure company, the Volocopter company, civil aviation authority ENAC and its infrastructure unit ENAV. "Rome will be one of the first capital cities in which this new means of transport, the electric helicopter, will start flying in 2024, in view of the Jubilee and the Expo bid," De Vincenti added. The Volocopter will be able to take passengers from Fiumicino to the centre of Rome in just 20 minutes. (ANSA).	estratto
6.3 (ANSA) - ROME, NOV 4 - Milan police on Friday announced restrictions on Inter's ultras for their home match against Bologna on November 9 after disorder in last Saturday's win over Sampdoria linked to the murder of a member of one of the hardcore fan groups. To pay homage to Vittorio Boiocchi, the ultras forced everyone out of the San Siro's 'Curva Nord' so it was empty as a sign of mourning. Boiocchi, 69, who had been ultra chieftain for at least two decades amid spells in jail and other trouble with the law, was shot in the head by a man who got off a motorbike or scooter while he was alone and off his guard, police said. The police said the ultras will not be allowed to take banners, flags, megaphones and drums into the stadium for the Bologna game. (ANSA).	estratto

<p>6.4 (ANSA) - ROME, NOV 8 - Italian police on Tuesday smashed a Mafia clan based in Catania which had been imposing the 'pizzo' protection racket on local firms for years. Hundreds of officers, helped by special teams, served 21 arrest warrants on members of the Lineri Clan of the Santapaola-Ercolano organization led by jailed superboss Benedetto 'Nitto' Santapaola.</p> <p>The mafiosi levied the 'pizzo' on local businessmen and traders for years, police said. Some 20 businesses were freed from the racket, they said.</p> <p>Those arrested have been charged with extortion, attempted robbery, receiving stolen goods, fraudulently taking over assets, and mafia association.</p> <p>he probe stated after a noted Catania restaurateur was threatened with two caliber 7.65 bullets in August 2019.</p>	non estratto
<p>6.5 (ANSA) - ROME, NOV 8 - After a short rainy break St Martin's Summer has returned to Italy with sunny spells across the country and temperatures well above seasonal averages. After a wet weekend in which temps fell by an average of 10 degrees Celsius, warm and sunny conditions have returned to the peninsula and temps should return to the very mild levels they showed last week, said meteorologist Mattia Gussoni of iLMeteo.it.</p> <p>There will, however, still be patchy rain in some parts, like Tuscany , Sicily, Puglia and Calabria on Tuesday.</p> <p>Gussoni said the fine conditions were due to the Atlantic cyclone moving off towards Turkey and a high-pressure area moving back into Italy.</p> <p>St Martin's Day, on Friday November 11, usually sees an unseasonable period of warm weather in any case.</p> <p>The day before St Martin's Day, hursday November 10, may paradoxically see more rain in many parts however, sais Gussoni.</p>	estratto
<p>6.6 ANSA) - ROME, NOV 8 - The Treasury on Tuesday approved a capital increase of 400 million euros for ITA Airways at an extraordinary assembly of the State-owned carrier's shareholders.</p> <p>Alfredo Altavilla quit as ITA's president and six board members also resigned ahead of Tuesday's meeting following friction over the process of selling the company, which replaced the loss-making Alitalia.</p> <p>Altavilla reportedly opposed a bid by US investment fund Certares, Delta Airlines and Air France-KLM and favoured one from German carrier Lufthansa and shipping group MSC.</p> <p>In August the government of ex-premier Mario Draghi announced it would start exclusive negotiations with the Certares-led bid, although there is speculation.</p>	non estratto

Last year's UN Cop26 climate talks in Scotland were framed by John Kerry, the US special presidential envoy on the climate crisis, as the "last best hope for the world to get its act together" and avert climate breakdown. As world leaders gather in Egypt for Cop27, evidence suggests they have yet to fully do so.</p> <p>The Glasgow conference drew collective promises by governments to "phase down" coal use, curb deforestation, advance remedial payments to developing countries hit hardest by floods, heatwaves and droughts, and to come back the following year with more ambitious emissions reduction targets.</p> <p>While the proliferation of clean energy is likely to have averted apocalyptic climate breakdown, where the world heats up by an average of 4-5C compared with pre-industrial times, a series of UN reports has made it clear that the world is lagging badly in its efforts to cut emissions, with "no credible pathway" to avoid breaching an agreed limit of 1.5C in global heating.</p>	non estratto
